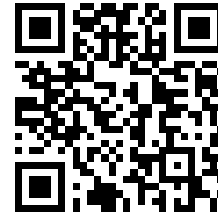



- (ii) The formal letter shall be issued after completion of all necessary paraphernalia viz. approval of all statutory bodies.


